5. Shareholding structure - Current CR12.
6. Identity/Passport copies and KRA PINs of the Directors.

Youth Category

1. Detailed company profile demonstrating experience of the organization and the team.
2. Certificate of incorporation/registration certificate.
3. Tax compliance certificate.
4. Access to Government Procurement Opportunities (AGPO) Certificate for youth.
5. Shareholding structure - Current CR12.
6. Identity/Passport copies and KRA PINs of the Directors.
7. All the directors/shareholders as per CR12 should be below 35 years of age.

PWDs

1. Detailed company profile demonstrating experience of the organization and the team.
2. Certificate of incorporation/registration certificate.
3. Tax compliance certificate.
4. AGPO Certificate (PWD) OR certificate from National Council of Persons with disabilities. (NCPWD Certificate)
5. Shareholding structure - Current CR12.
6. Identity/Passport copies and KRA PINs of the Directors.

- B. Shortlisting of potential Women, Youth and PWD companies
- C. Prequalification of shortlisted companies in line with our procurement process
