The Retail Strategy team wishes to engage a firm with the relevant experience that can provide the current uniforms on time and without compromise on quality.

The beginning of our engagement with this firm will be the reproduction of the current uniform for replenishing to staff, with a few tweaks which will be communicated.

As time progresses the firm will be tasked with the sourcing / production of a new look uniform for customer facing staff.

It is expected that the supplier/ firm is aware of current international trends across the telecommunications Retail industry and is willing to demonstrate innovation which will put the Retail team ahead of competition and offer staff comfort as well as function in their uniform regardless of workstation location.

Objectives

The assignment and the achievements expected include:

- Replenish the current uniforms for all Retail channel staff across the country in the correct sizes.
- Provide a means to return and replace uniform within 72hrs where needed.
- Be capable of production of uniforms for 4000 staff at one go effortlessly.
- Be able to provide Cotton Shirts and blouses and Khaki/ chino pants and or skirts made to fit, Leather belts and high-quality Polo shirts.
- Be able to source & provide name tags/ window badges.
- Provide a process map or Gantt chart showing process flow for production.

1.3. Submission of Responses

The Expression of interest (EOI) is intended to lead to identification and shortlisting of a reputable firm/s to provide Safaricom Retail Staff with uniform.



Safaricom is therefore soliciting the following documents from interested companies.

- Expression of Interest letter duly dated signed and stamped.
- A proposal clearly showing the following:
 - a. Capacity-Daily run-rate
 - b. References/List of clients' companies where uniform (Top to Bottom) has been provided for upwards of 4000 items for a single client.
 - c. Quality control procedures that are ISO certified
 - d. Indicate if based within Kenya. If not locally based, detail how you intend to conduct the assignment.
 - e. Indicate presence outside of Nairobi for support to regional shop staff.
 - f. Provide physical samples of uniforms, one unit each of: Male-Shirt, trouser, sweater & Female-Trouser, skirt, blouse, sweater.
 - g. Any value adding service that may enhance the overall customer's experience.
